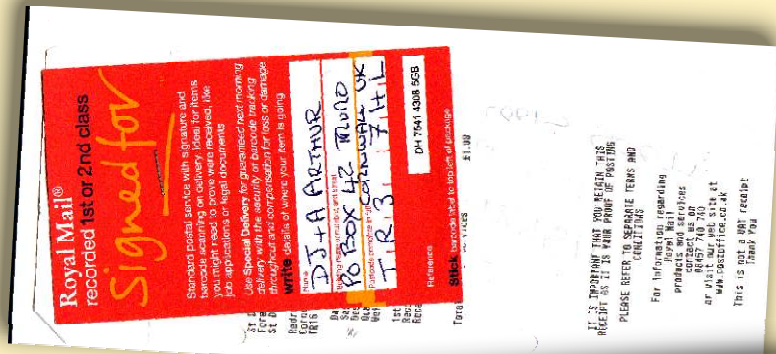
“Signed for” items posted to the Claimants that have been “lost in the post”

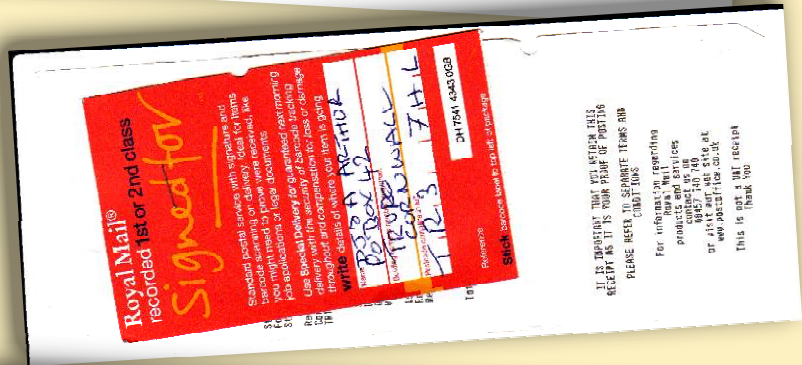

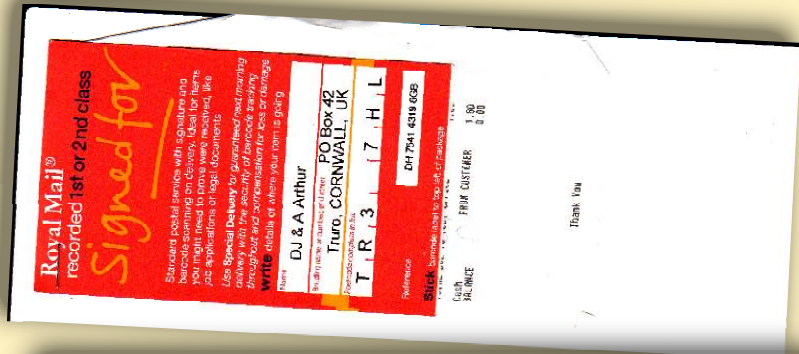
